FAMILY HOME: THE FREDDIE MAC FOUNDATION FAMILY HOME, DOORWAYS' FAMILY HOME, IS A THERAPEUTIC HOME THAT CAN WELCOME 21 INDIVIDUALS - SEVEN TO NINE FAMILIES - IN A FAMILY-FRIENDLY AND SUPPORTIVE ENVIRONMENT. IT PROVIDES A TEMPORARY HOME FOR WOMEN AND FAMILIES WHO ARE HOMELESS, 24-HOURS A DAY, 365 DAYS A YEAR. DURING THEIR STAY, FAMILIES ARE SUPPORTED IN DEVELOPING AND ACHIEVING GOALS TOWARD PERMANENT HOUSING AND SELF-SUFFICIENCY. EVERYONE IS OFFERED SERVICES TO HELP ADDRESS THE TRAUMA FAMILY MEMBERS EXPERIENCE WITH HOMELESSNESS. HIGHLIGHTS FROM FISCAL YEAR 2016 INCLUDE:
- SHELTERED 36 ADULTS AND 41 CHILDREN (30 FAMILIES) PROVIDING 5,553 BED NIGHTS.

DOMESTIC VIOLENCE: THE DOMESTIC AND SEXUAL VIOLENCE PROGRAM OPERATES AN 11-BED SAFE-HOUSE SHELTER, A 2-BEDROOM, APARTMENT-BASED SCATTERED SITE EMERGENCY SHELTER, A 24/7 DOMESTIC AND SEXUAL VIOLENCE HOTLINE, AND A BILINGUAL COURT ADVOCACY AND COMPANIONSHIP PROGRAM. DOORWAYS PROVIDES THE ONLY SAFE-HOUSE IN ARLINGTON COUNTY AND IS THE LARGEST PROVIDER OF DOMESTIC AND SEXUAL VIOLENCE SERVICES IN ARLINGTON, VIRGINIA. IN ADDITION TO EMERGENCY SHELTER, DOORWAYS PROVIDES CLIENTS WITH WRAP AROUND SERVICES TO SUPPORT THEM IN OVERCOMING TRAUMA AND CHALLENGES THAT COULD IMPEDE LONG-TERM SAFETY AND STABILITY (SEE MORE DETAIL IN SECTION BELOW).
